AND WHEREAS for that purpose only and to ensure perpetual existence, have now decided to create a Trust to manage the said educational institution with an aim to diversify the educational institution in the various educational spheres mostly relating to computers, scientific and modern education including religious, philosophy and moral instruction and study.

AND WHEREAS the Authors of the Trust desire to Irrevocably endowing and transferring fund to the trust for objects and purposes of the Trust, as hereinafter expressed and contained in this presents and in pursuance of such desire have already transferred paid and handed over the said institution to the trustees mentioned below.

AND WHEREAS it is desired of the Authors of the Trust that the Corpus of the Trust may be further augmented from time to time by flow of funds and other assets including moveable and immovable and any other kind by way of Gifts, or Donations, acquisition, allotments, grant exchange or otherwise etc.

AND WHEREAS THE AUTHORS above named has settled a sum of Rs.75,000/- (Rupees Seventy five thousand only) as a fund.

AND WHEREAS the following persons are appointed to be trustees for holding the said property in Trust for the purposes detailed in this trust Deed.

1. **PARTHA BANERJEE** son of Late Kashi Nath Banerjee residing at Vill & P.O. Baduria, District -24 Parganas North, Baduria, Pin -743401.
2. **MANAS ARATDAR** son of Shri Bhismadeb Aratdar residing at Vill & P.O.- Arbalia, Aratdar Para, Municipal Ward No.8, P.S. :- Baduria, District -24 Parganas North, Arbalia, Pin-743437.

3. **MADHURI GHOSH** wife of Mr. Kallol Kumar Ghosh of House No.1202, KBM, P.O. & P.S. : Chakdaha, District – Nadia, Pin-741222.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. NAME:

The trust hereby established shall be named as **"SOCIAL WELFARE & EDUCATIONAL TRUST OF BADURIA"**.

2. PLACE:

Office of the Trust shall be situated at Vill & P.O.- Arbalia, Aratdar Para, Municipal Ward No.8, P.S. :- Baduria, District -24 Parganas North, Arbalia, Pin-743437 or at such other place in India as the Trustees may from time to time think fit. The Trust shall be a registered Trust.

3. OBJECTS: The objects for which the Trust is founded are

- a. To establish, maintain and run Schools, Colleges and Social service Centers.
- b. To establish, Training Centre, and allied education institutions.
- c. To spread for promotions of education and learning in all branches including preferential and technical skills and more specifically in the areas of Science and Technology.
- d. To advance the study of Indian and other Cultures and Literatures, welfare, educational and Health services for free or concession basis for ameliorating and improvement of the standard of life of the poorer sections of the people of the country as also facilities to be provided to others who in the view of the Trustees are able to pay for such service.
- e. To train teachers and workers in ideals and practice of the true spirit of the education and learning.
- f. To establish research and training centers for the furtherance of education/learning in it's various fields and branches.
- g. To undertake publicity, dissemination of cultural, spiritual and moral literature, education of the masses either of its own or in co-operation with similar agencies working for the cause of all round development of the society.

IN PURSUANCE OF THE ABOVE OBJECT THE TRUST MAY :

- a. Acquire, by purchase, lease, mortgage, will gift grant, legacy, bequest, exchange, right privilege or otherwise from any person, company, society, Government, institution(s), organization(s) or anybody whosoever moveable or immoveable properties of description deemed necessary or useful for desired purpose of the trust.
- b. Free buildings or structures whatsoever to further any purpose of the Trust and to maintain, develop, improve, alter, repair, demolish or reconstruct the same or any portion thereof.
- c. Take or receive any gifts, whether money or property, moveable or immoveable, donation in the form of debentures, stocks, shares or securities in any company or society whether incorporated or not or whether by gift by a person living or by legacy bequests, will of foundation and whether subject to any special trust for works connected therewith and to take steps for securing such contributions for funds as from time to time be deemed expedient.
- d. Alienate by way of sale, mortgage, lease, release, loan, charge, hypothecation, pledge, exchange, hiring out, gift or otherwise with or without security of properties or funds of the trust or any portion thereof including the making or giving of subscriptions, contributions, assistance, pecuniary or otherwise to such institutions, bodies or persons as from time to time deemed necessary or expedient.
- c. Lend money free of interest, invest, lay aside, deposit in Bank or otherwise deal with the monetary fund of the trust not immediately required for the objects of the trust and to subscribe or purchase, acquire, hold, sell, endorse and negotiate in debentures, stocks, shares and securities of every description in the money market in the conformity with the provision contained in section 20 of the Indian Trust Act, 1882.

- f. Borrow or raise funds with or without security in any manner whatsoever the Trust may think fit and repay the same.
- g. Negotiate with and enter into arrangements, with any Government, Authority, Corporation, Board University or other public or private bodies as may seem conducive to the promotion or accomplishment of the objects of the trust or any of them and to apply for obtain, collect, receive such grants, loans, allowance, rights, concessions and privileges as may seem to comply with the objects of the trust and utilize the same.
- h. In general do or cause to be done apart from all the acts stated above, all such other acts or things as shall be conducive to the interests of the trust provided such things or acts be not contrary to nor inconsistent with the spirit and the principals of law under which the Trust has been established.
- i. The Board shall be entitled to and is hereby expressly authorized to invest the Trust Fund or any money subject to the provisions of the trust act 1950 and accordance with u/s 11(5) of I.T. Act, 1961 in any securities or investment or Immoveable Properties shall be which made strictly in name of the trust and shall be held by any two or more Trustees as may be decided by the Board.
- j. No amendments to the Trust Deed/Memorandum of Trust and rules and regulations shall be made which may prove to be repugnant to the provisions of section 2(15), 11, 12, 13 and 80th of the Income Tax Act, 1961. Further, no amendments shall be carried out without the prior approval of the commissioner of Income Tax.
- k. The funds and the income of the Trust/Society/Association/Institution shall be solely utilized towards the activities within the country only.

4. NUMBER OF TRUSTEES:

The number of Trustees including the Authors of the Trustees shall not be less than 3 (three) and not more than 7 (seven persons). The board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

5. TERM OF OFFICE OF THE TRUSTEES:

The Trustees shall hold office for such duration as may be specified by the Board of Trustees. But so however that the Authors/Settlers of the Trust shall continue without any interruption or hindrance so long as any or all of them wish to continue but in case of any vacancy in the board of Trustees due to death, resignation or retirement, the remaining Trustees shall appoint a person whom they consider fit and proper to be a trustee for such period. In case of the three trustees who are the authors in the event of their death, resignation or otherwise relinquishment of office, the first option shall be for any one of the sons or daughters of such Trustees as may be determined among by themselves. The sons and daughters of such trustee in writing to fill such vacancy but in the event of no such agreement the other Authors shall be entitled to fill such vacancy.

6. PRESIDENT:

There shall be a president for the administration of this trust, nominated by the board of Trustees, who shall be Mr. Partha Banerjee son of Late Kashi Nath Banerjee residing at Vill & P.O. Baduria, District -24 Parganas North, Baduria, Pin -743401 being on the trustees as specified in para (4) above for such period, in such manner as may be specified in this behalf.

7. MANAGING TRUSTEE:

There shall be two Managing Trustees for the administration of this trust, nominated by the board of trustees, who shall be Mr. Manas Aratdar and Mrs. Madhuri Ghosh being on the Trustees.

- i. The day-to-day administration of the Trust shall be looked after by the managing trustee under the guidance, control and supervision of the board of trustees.
- ii. The board of trustees shall nominate two amongst the trustees as specified in para (4) above to be the managing Trustee, who shall help office for such period, as may be decided by the board of Trustees.
- iii. The Managing Trustees shall perform all functions, discharge such duties as or specifically entrusted to him in writing by the board of trustees.

8. VACANCIES:

Any vacancy among the Members of the Board of Trustees may be filled by the Trustees as specified in para (5) above or their successors and they shall hold for such duration as may be specified by board of Trustees.

9. TERMINATION OF OFFICE OF THE TRUSTEES**a) Trustees shall cease to hold office:**

- i. If he dies.
- ii. If he resigns.
- iii. If he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- iv. If he is found to have acted against the interest of the Trust.
- v. If it is unanimously decided by the trustees specified in para (4) above that his continuation in the office is against the interest of the Trust.
- vi. Upon expiry of the period upto which the board of trustees have nominated the trustees.

10. MEETING AND PROCEEDING OF THE TRUSTEES:

The Trustees shall ordinarily meet once in 1 (one) month or as often as may be necessary for the satisfactory conduction of the affairs of the trust.

11. NOTICE:

At least 07 (seven) days prior Notice shall ordinarily be given in writing for meeting of Board of Trustees.

12. Quorum:

The Quorum for the meeting of the board of trustees shall be the presence of 2/3 members failing which a meeting may be adjourned for want of Quorum.

A minute book shall be kept by the Managing Trustees. Minutes of entry into the office of every new trustee and of all proceeding of the meeting of the board of trustee shall be entered in the minute book and shall be signed by the president of the meeting.

13. VOTING:

Decisions of the board of trustees may be made at a meeting or by circulation of papers by them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided by a majority of the board of trustees present at the Meeting. The President of the board of trustees shall have a casting vote in the event of equality of votes, in addition to his own at his discretion and if he so elects to caste such casting veto.

14. POWERS FUNCTIONS AND DUTIES OF THE TRUSTEES:

All property of the Trust Movable or immovable or any other kind, shall vest in trust, the trustees shall manage the whole property and affair of the trust and shall have all the powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.

In particular and without prejudice to the generality of the forgoing the trustees shall for the purposes of this trust have the following powers, duties and function.

- I. To acquire by Gift, Grant, Purchase, Exchange, Lease or otherwise, lands, buildings, or other immovable properties and also any moveable Property.
- II.
- III. To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
- IV. To accept gifts, donation, endowment and contribution for the trust and shall be treated as income of the trust.
- V. (a) To raised loans, to receive monies, securities or other movable property on behalf of the trust on terms and conditions as may be agreed upon by the Board of Trustees.
(b) To accept any trust, trust fund or endowments are in consonance with the object of the Trust on terms and conditions as may be agreed upon by the board of Trustees.
- VI. To award scholarship and make donations calculated to promote the objects of the trust.
- VII. (a) To enter into contracts, or engagements on behalf of the trust.
(b) To consider such proposals submitted by Subcommittee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the Programmers.
- VIII. To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the trust.
- IX. To invest such monies and such funds of the trust and to vary the Investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
- X. To sell, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
- XI. To appoint a committee/ Committees of management for such terms and with such powers as may be specified from time to time for carrying on the routine management of the affair of the Trust.

- XII. To appoint such employees on such terms and conditions as the trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
- XIII. To frame Bye-laws and such other regulations as are required from achieving its objectives.
- XIV. Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely.
 - a) All rates, taxes, cess, assessments, dues and duties if any payable to the Government to any municipal or other public bodies in respect thereof.
 - b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
 - c) The cost of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
 - d) The cost of making such additions/ alterations or improvements to or in the building forming part of the trust Property, as the Trustees shall think fit.
 - e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this Trust.
 - f) Cost and Expenses of keeping the trust property in good condition.
 - g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
 - h) The architect's fee and legal charges and fee payable to other professional engaged in the course of administration of the trust.
 - i) All other costs including lease rent, if any, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purpose thereof or which may be incidental thereto.

After deducting the cost charges and expenses incurred by the trustees as aforesaid out of the total gross income received by them from the trust property, the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

15. BANK ACCOUNT:

- I. The Board of trustees may open such bank account or accounts in any of the Banks in the name of "**SOCIAL WELFARE & EDUCATIONAL TRUST OF BADURIA**" and such accounts shall be jointly operated by the President and one of the Managing Trustee or as decided mutually.
- II. The trust may open Bank Account/s in the name of institution/organization Founded by the trust. Such Bank Accounts shall be operated by such persons as authorized by the Board of trustees from time to time.

16. APPLICATION OF THE PROPERTIES OF THE TRUST:

The properties and funds of the trust shall be applied only for the purpose of the trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or honorarium or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried on by him/her for the purpose of the trust as may be so decided and awarded by the board of trustees by at least 2/3rd majority at a meeting of the board of trustees at which at least two of the authors are present.

17. ACCOUNTS:

The trustees shall maintain a true and correct record of the receipts, payments, incomes and expenses and transactions of the trust. The Book of the Accounts of the trust shall be audited by a qualified auditor or Chartered Accountant every year i.e. commencing from the date of the execution of this deed to 31st march next year.

18. DEFECTS OF PROCEDURE IMMATERIAL :

No act of trustees shall be invalidated by reason only of any vacancy in the board of trustees or any irregularity in the proceedings of the board of trustees or any committee thereof so long as the board of trustees have at least five members of whom a majority decide in favour of such act or action.

19. AMENDMENTS:

No amendments to the trust deed shall be made which may prove to be repugnant to the provisions of section 2 (15), 11, 12 and 13 and 80G of the Income tax Act, 1961 as amended from time to time.

While this Trust shall be irrevocable, the board of trustees may amend any of the clauses except those relating to objects of the Trust, the First Managing Trustee and first trustees, at a duly convened meeting of the Board with at least 2 weeks' notice, and by a resolution passed by at least three-fourth majority of the board of trustees present and voting. The amendments to the trust deed, can only be passed by a resolution of the board of trustees in an actual meeting and not by a circulation. If any alteration or amendment is necessary, the same shall be annexed through supplementary deed/deeds with the previous approval of the commissioner of Income Tax and these shall be read together with the main Trust deed.

20. DISSOLUTION:

In the event of the dissolution or the winding up of the Trust the assets remaining on the dissolution shall be transferred to another Trust, Society or Institution whose objects are similar to those of this Trust and that is no event shall so remaining be distributed among the Trustees.

That the trust created by these presents shall be irrevocable provided that in the event of the trust failing to function for any reason, or in the event of the trustees being of the unanimous opinion that this trust shall be dissolved or amalgamated with any other trust having the objects more or less similar to this trust registered under section 12 A of Income Tax Act, 1961.

AND WHEREAS the following persons are appointed to be trustees for holding the said property in Trust for the purposes detailed in this trust Deed.

1. **PARTHA BANERJEE** son of Late Kashi Nath Banerjee residing at Vill & P.O. Baduria, District -24 Parganas North, Baduria, Pin -743401.
2. **MANAS ARATDAR** son of Shri Bhismadeb Aratdar residing at Vill & P.O.- Arbalia, Aratdar Para, Municipal Ward No.8, P.S. :- Baduria, District -24 Parganas North, Arbalia, Pin-743437.

3. **MADHURI GHOSH** wife of Mr. Kallol Kumar Ghosh of House No.1202, KBM, P.O. & P.S. : Chakdaha, District – Nadia, Pin-741222.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. NAME:

The trust hereby established shall be named as **"SOCIAL WELFARE & EDUCATIONAL TRUST OF BADURIA"**.

2. PLACE:

Office of the Trust shall be situated at Vill & P.O.- Arbalia, Aratdar Para, Municipal Ward No.8, P.S. :- Baduria, District -24 Parganas North, Arbalia, Pin-743437 or at such other place in India as the Trustees may from time to time think fit. The Trust shall be a registered Trust.

3. OBJECTS: The objects for which the Trust is founded are

- a. To establish, maintain and run Schools, Colleges and Social service Centers.
- b. To establish, Training Centre, and allied education institutions.
- c. To spread for promotions of education and learning in all branches including preferential and technical skills and more specifically in the areas of Science and Technology.
- d. To advance the study of Indian and other Cultures and Literatures, welfare, educational and Health services for free or concession basis for ameliorating and improvement of the standard of life of the poorer sections of the people of the country as also facilities to be provided to others who in the view of the Trustees are able to pay for such service.
- e. To train teachers and workers in ideals and practice of the true spirit of the education and learning.
- f. To establish research and training centers for the furtherance of education/learning in it's various fields and branches.
- g. To undertake publicity, dissemination of cultural, spiritual and moral literature, education of the masses either of its own or in co-operation with similar agencies working for the cause of all round development of the society.

IN PURSUANCE OF THE ABOVE OBJECT THE TRUST MAY :

- a. Acquire, by purchase, lease, mortgage, will gift grant, legacy, bequest, exchange, right privilege or otherwise from any person, company, society, Government, institution(s), organization(s) or anybody whosoever moveable or immoveable properties of description deemed necessary or useful for desired purpose of the trust.
- b. Free buildings or structures whatsoever to further any purpose of the Trust and to maintain, develop, improve, alter, repair, demolish or reconstruct the same or any portion thereof.
- c. Take or receive any gifts, whether money or property, moveable or immoveable, donation in the form of debentures, stocks, shares or securities in any company or society whether incorporated or not or whether by gift by a person living or by legacy bequests, will of foundation and whether subject to any special trust for works connected therewith and to take steps for securing such contributions for funds as from time to time be deemed expedient.
- d. Alienate by way of sale, mortgage, lease, release, loan, charge, hypothecation, pledge, exchange, hiring out, gift or otherwise with or without security of properties or funds of the trust or any portion thereof including the making or giving of subscriptions, contributions, assistance, pecuniary or otherwise to such institutions, bodies or persons as from time to time deemed necessary or expedient.
- c. Lend money free of interest, invest, lay aside, deposit in Bank or otherwise deal with the monetary fund of the trust not immediately required for the objects of the trust and to subscribe or purchase, acquire, hold, sell, endorse and negotiate in debentures, stocks, shares and securities of every description in the money market in the conformity with the provision contained in section 20 of the Indian Trust Act, 1882.

- f. Borrow or raise funds with or without security in any manner whatsoever the Trust may think fit and repay the same.
- g. Negotiate with and enter into arrangements, with any Government, Authority, Corporation, Board University or other public or private bodies as may seem conducive to the promotion or accomplishment of the objects of the trust or any of them and to apply for obtain, collect, receive such grants, loans, allowance, rights, concessions and privileges as may seem to comply with the objects of the trust and utilize the same.
- h. In general do or cause to be done apart from all the acts stated above, all such other acts or things as shall be conducive to the interests of the trust provided such things or acts be not contrary to nor inconsistent with the spirit and the principals of law under which the Trust has been established.
- i. The Board shall be entitled to and is hereby expressly authorized to invest the Trust Fund or any money subject to the provisions of the trust act 1950 and accordance with u/s 11(5) of I.T. Act, 1961 in any securities or investment or Immoveable Properties shall be which made strictly in name of the trust and shall be held by any two or more Trustees as may be decided by the Board.
- j. No amendments to the Trust Deed/Memorandum of Trust and rules and regulations shall be made which may prove to be repugnant to the provisions of section 2(15), 11, 12, 13 and 80th of the Income Tax Act, 1961. Further, no amendments shall be carried out without the prior approval of the commissioner of Income Tax.
- k. The funds and the income of the Trust/Society/Association/Institution shall be solely utilized towards the activities within the country only.

4. NUMBER OF TRUSTEES:

The number of Trustees including the Authors of the Trustees shall not be less than 3 (three) and not more than 7 (seven persons). The board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

5. TERM OF OFFICE OF THE TRUSTEES:

The Trustees shall hold office for such duration as may be specified by the Board of Trustees. But so however that the Authors/Settlers of the Trust shall continue without any interruption or hindrance so long as any or all of them wish to continue but in case of any vacancy in the board of Trustees due to death, resignation or retirement, the remaining Trustees shall appoint a person whom they consider fit and proper to be a trustee for such period. In case of the three trustees who are the authors in the event of their death, resignation or otherwise relinquishment of office, the first option shall be for any one of the sons or daughters of such Trustees as may be determined among by themselves. The sons and daughters of such trustee in writing to fill such vacancy but in the event of no such agreement the other Authors shall be entitled to fill such vacancy.

6. PRESIDENT:

There shall be a president for the administration of this trust, nominated by the board of Trustees, who shall be Mr. Partha Banerjee son of Late Kashi Nath Banerjee residing at Vill & P.O. Baduria, District -24 Parganas North, Baduria, Pin -743401 being on the trustees as specified in para (4) above for such period, in such manner as may be specified in this behalf.

7. MANAGING TRUSTEE:

There shall be two Managing Trustees for the administration of this trust, nominated by the board of trustees, who shall be Mr. Manas Aratdar and Mrs. Madhuri Ghosh being on the Trustees.

- i. The day-to-day administration of the Trust shall be looked after by the managing trustee under the guidance, control and supervision of the board of trustees.
- ii. The board of trustees shall nominate two amongst the trustees as specified in para (4) above to be the managing Trustee, who shall help office for such period, as may be decided by the board of Trustees.
- iii. The Managing Trustees shall perform all functions, discharge such duties as or specifically entrusted to him in writing by the board of trustees.

8. VACANCIES:

Any vacancy among the Members of the Board of Trustees may be filled by the Trustees as specified in para (5) above or their successors and they shall hold for such duration as may be specified by board of Trustees.

9. TERMINATION OF OFFICE OF THE TRUSTEES

a) Trustees shall cease to hold office:

- i. If he dies.
- ii. If he resigns.
- iii. If he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- iv. If he is found to have acted against the interest of the Trust.
- v. If it is unanimously decided by the trustees specified in para (4) above that his continuation in the office is against the interest of the Trust.
- vi. Upon expiry of the period upto which the board of trustees have nominated the trustees.

10. MEETING AND PROCEEDING OF THE TRUSTEES:

The Trustees shall ordinarily meet once in 1 (one) month or as often as may be necessary for the satisfactory conduction of the affairs of the trust.

11. NOTICE:

At least 07 (seven) days prior Notice shall ordinarily be given in writing for meeting of Board of Trustees.

12. Quorum:

The Quorum for the meeting of the board of trustees shall be the presence of 2/3 members failing which a meeting may be adjourned for want of Quorum.

A minute book shall be kept by the Managing Trustees. Minutes of entry into the office of every new trustee and of all proceeding of the meeting of the board of trustee shall be entered in the minute book and shall be signed by the president of the meeting.

13. VOTING:

Decisions of the board of trustees may be made at a meeting or by circulation of papers by them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided by a majority of the board of trustees present at the Meeting. The President of the board of trustees shall have a casting vote in the event of equality of votes, in addition to his own at his discretion and if he so elects to caste such casting veto.

14. POWERS FUNCTIONS AND DUTIES OF THE TRUSTEES:

All property of the Trust Movable or immovable or any other kind, shall vest in trust, the trustees shall manage the whole property and affair of the trust and shall have all the powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.

In particular and without prejudice to the generality of the forgoing the trustees shall for the purposes of this trust have the following powers, duties and function.

- I. To acquire by Gift, Grant, Purchase, Exchange, Lease or otherwise, lands, buildings, or other immovable properties and also any moveable Property.
- II.
- III. To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
- IV. To accept gifts, donation, endowment and contribution for the trust and shall be treated as income of the trust.
- V. (a) To raised loans, to receive monies, securities or other movable property on behalf of the trust on terms and conditions as may be agreed upon by the Board of Trustees.
(b) To accept any trust, trust fund or endowments are in consonance with the object of the Trust on terms and conditions as may be agreed upon by the board of Trustees.
- VI. To award scholarship and make donations calculated to promote the objects of the trust.
- VII. (a) To enter into contracts, or engagements on behalf of the trust.
(b) To consider such proposals submitted by Subcommittee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the Programmers.
- VIII. To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the trust.
- IX. To invest such monies and such funds of the trust and to vary the Investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
- X. To sell, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
- XI. To appoint a committee/ Committees of management for such terms and with such powers as may be specified from time to time for carrying on the routine management of the affair of the Trust.

- XII. To appoint such employees on such terms and conditions as the trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
- XIII. To frame Bye-laws and such other regulations as are required from achieving its objectives.
- XIV. Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely.
 - a) All rates, taxes, cess, assessments, dues and duties if any payable to the Government to any municipal or other public bodies in respect thereof.
 - b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
 - c) The cost of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
 - d) The cost of making such additions/ alterations or improvements to or in the building forming part of the trust Property, as the Trustees shall think fit.
 - e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this Trust.
 - f) Cost and Expenses of keeping the trust property in good condition.
 - g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
 - h) The architect's fee and legal charges and fee payable to other professional engaged in the course of administration of the trust.
 - i) All other costs including lease rent, if any, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purpose thereof or which may be incidental thereto.

After deducting the cost charges and expenses incurred by the trustees as aforesaid out of the total gross income received by them from the trust property, the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

15. BANK ACCOUNT:

- I. The Board of trustees may open such bank account or accounts in any of the Banks in the name of "**SOCIAL WELFARE & EDUCATIONAL TRUST OF BADURIA**" and such accounts shall be jointly operated by the President and one of the Managing Trustee or as decided mutually.
- II. The trust may open Bank Account/s in the name of institution/organization Founded by the trust. Such Bank Accounts shall be operated by such persons as authorized by the Board of trustees from time to time.

16. APPLICATION OF THE PROPERTIES OF THE TRUST:

The properties and funds of the trust shall be applied only for the purpose of the trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or honorarium or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried on by him/her for the purpose of the trust as may be so decided and awarded by the board of trustees by at least 2/3rd majority at a meeting of the board of trustees at which at least two of the authors are present.

17. ACCOUNTS:

The trustees shall maintain a true and correct record of the receipts, payments, incomes and expenses and transactions of the trust. The Book of the Accounts of the trust shall be audited by a qualified auditor or Chartered Accountant every year i.e. commencing from the date of the execution of this deed to 31st march next year.

18. DEFECTS OF PROCEDURE IMMATERIAL :

No act of trustees shall be invalidated by reason only of any vacancy in the board of trustees or any irregularity in the proceedings of the board of trustees or any committee thereof so long as the board of trustees have at least five members of whom a majority decide in favour of such act or action.

19. AMENDMENTS:

No amendments to the trust deed shall be made which may prove to be repugnant to the provisions of section 2 (15), 11, 12 and 13 and 80G of the Income tax Act, 1961 as amended from time to time.

While this Trust shall be irrevocable, the board of trustees may amend any of the clauses except those relating to objects of the Trust, the First Managing Trustee and first trustees, at a duly convened meeting of the Board with at least 2 weeks' notice, and by a resolution passed by at least three-fourth majority of the board of trustees present and voting. The amendments to the trust deed, can only be passed by a resolution of the board of trustees in an actual meeting and not by a circulation. If any alteration or amendment is necessary, the same shall be annexed through supplementary deed/deeds with the previous approval of the commissioner of Income Tax and these shall be read together with the main Trust deed.

20. DISSOLUTION:

In the event of the dissolution or the winding up of the Trust the assets remaining on the dissolution shall be transferred to another Trust, Society or Institution whose objects are similar to those of this Trust and that is no event shall so remaining be distributed among the Trustees.

That the trust created by these presents shall be irrevocable provided that in the event of the trust failing to function for any reason, or in the event of the trustees being of the unanimous opinion that this trust shall be dissolved or amalgamated with any other trust having the objects more or less similar to this trust registered under section 12 A of Income Tax Act, 1961.
